2010 Tournament Rules – July 17, 2010
One Day Tournament

1. Rules Meeting: Saturday morning, July 17th at 6:00 a.m.
2. Fishing hours: Team 1 thru--- will depart at 7:30 a.m.
Team 1 thru--- will return at 3:30 p.m.
3. All boats will be checked in the morning before the start of the tournament (mandatory).
4. All boats must depart from Nitti's Hunters Point Resort.
5. All walleyes entered must be from Mille Lacs Lake and weighed in at Nitti's Hunters Point Resort.
6. Weigh seven fish per day per team. Your fish must be from 13" to just under 18" and (2) fish over 28". (Subject to change, will be announced at the rules meeting.)
7. The longest straight line of measurement will be used to determine length by pinching the nose and tail. The "Judge" will be the official ruler.
8. Any fish altered in an attempt to increase weight or increase/decrease length will result in disqualification.
9. Contestants' boats may not come within 50 feet of any other boat.
10. Minnesota fishing laws will prevail.
11. No marine radio or cellular phone communication during tournament hours, except in an emergency situation.
12. At no time during tournament hours may a contestant leave his/her boat unless he/she returns to tournament headquarters and permission is obtained from the tournament official. Use good judgment during unsafe weather conditions.
13. All boats must be checked in per the above time schedule.
14. If you are 1 to 15 minutes late you will be penalized 50% of your weight for that day.
15. A protest must be filed with tournament director before weigh-in is completed. A \$200.00 fee will be required (refunded if protest is found valid). A protest committee will consist of two (2) tournament officials and three (3) randomly picked contestants. The committee findings will be final. If a polygraph test is recommended by the committee, money will be withheld until the results of the polygraph test are known.
16. The violation of any rules, as determined by the tournament judges in their sole discretion, shall result in automatic disqualification from the tournament and ineligibility for any prizes or awards.
17. All judge's decisions are final and binding on contestants and may not be challenged.
18. A life vest must be worn when your main motor is above trolling speed.
19. Promoters, tournament directors, and organizations assisting in the tournament operations are not responsible for death, injury, damage, liability, theft, fire, or loss of any kind to the entrants. Each entrant, upon signing an entry form, will in effect be signing a waiver form.
20. All contestants competing in the Nitti's Hunters Point Resort Couple's Tournament are expected to act in a sportsman-like manner at all times towards non-competitors and competitors alike. This shall include the areas of safety, conservation, and courtesy. Violators of this rule will be disqualified. Any unfavorable conduct or action by a competitor which could negatively reflect on George and Linda Nitti, or Nitti's Hunters Point Resort will be grounds for disqualification or rejection of entry of application.
