- Tournament is based on 100 boats. If tournament exceeds 100 boats, payback would increase accordingly. Paybacks are also subject to change if there is a dinner also.

- Lodge opens at 4:30 a.m. Friday and Saturday. Breakfast is available.
- Outside tents will be available with food and drink. If inclement weather, we will move inside lodge.
- Boat Ramp: Hunters Point Resort. Check where to launch your boat at the rules meeting.

Whether or not we have a dinner Friday Evening will be determined by a majority vote from everyone who signs up prior to June 1st, 2010
There will be a box to check right on your entry forms.

2010 Tournament Rules • June 25 & 26, 2010

1. Rules & registration meeting: Thursday evening, June 24th at 7:00 p.m. at Hunters Point Resort.
2. Fishing Hours: Friday Team# 1 thru 100 will depart in numerical order at 7 a.m.
 Team # 1 thru 50 will return at 4:00 p.m.
 Team # 51 thru 100 will return at 5:00 p.m.
 Saturday Team # 100 thru 1 will depart in numerical order at 7 a.m.
 Team # 51 thru 100 will return at 4:00 p.m.
 Team # 1 thru 50 will return at 5:00 p.m.
3. All boats will be checked each morning before the start of the tournament (mandatory).
4. All boats must depart from Nitti's Hunters Point Resort.
5. All walleyes entered must be from Mille Lacs Lake and weighed in at Nitti's Hunters Point Resort.
6. Eight fish per day per team allowed in live well, but you only weigh seven. Your fish must be from 13" to just under 18" and (1) fish over 28" per person. This is a no cull tournament, once you put the eighth fish in the boat you have to come in. (Subject to change, will be announced at Thursday's meeting.)
7. The longest straight line of measurement will be used to determine length by pinching the nose and tail. The "Judge" will be the official rule.
8. Any fish altered in an attempt to increase weight, increase or decrease length will result in team disqualification.
9. Contestants' boats may not come within 50 feet of another boat.
10. Minnesota fishing laws will prevail.
11. No pre-fishing after 4:00 p.m. on June 24, 2010.
12. No fishing before or after tournament hours on tournament days.
13. No alcoholic beverages may be consumed during tournament hours.
14. No marine radio or cell phone communication during tournament hours except in an emergency.
15. At NO time during tournament hours may a contestant leave his/her boat unless he/she returns to tournament headquarters and permission is obtained from a tournament official. Use good judgment during unsafe weather conditions.
16. All boats must be checked in per the above time schedule. There will be an official's boat on the lake in front of the entrance to Nitti's Hunters Point Resort. Check in both days, fish or no fish. This is mandatory.
17. If you are 1 to 15 minutes late you will be penalized 50% of your weight for that day. After 15 minutes, you fish will not be weighed.
18. A protest must be filed with the tournament director before weigh-in is completed. A \$1,000.00 fee will be required, refunded if the protest is found to be valid. A protest committee will consist of two tournament officials and three randomly picked contestants. The committee findings will be final. If the committee recommends a polygraph test, moneys will be withheld until the results of the test are known.
19. The violation of any rule, as determined by the tournament judges in their sole discretion, shall result in automatic disqualification from the tournament and ineligibility for any prizes or awards.
20. All judges' decisions are final and binding on contestants, and may not be challenged.
21. A life vest must be worn when your main motor is above trolling speed.
22. Promoters, tournament directors and organizations assisting in the tournament operations are not responsible for death, injury, damage, liability, theft, fire, or loss of any kind to an entrant. Each entrant, upon signing an entry form, will in effect be signing a waiver form.
23. All contestants competing in the Nitti's Hunters Point Resort, Inc. Walleye Tournament are expected to act in a sportsman like manner at all times towards non-competitors and competitors alike. This shall include the areas of safety, conservation and courtesy. Violators of this will be disqualified. Any unfavorable conduct or action by a competitor, which could negatively reflect on Gorge and Linda Nitti, or Nitti's Hunters Point Resort, Inc. will be grounds for disqualification or rejection of entry of application.
24. All fish caught on the first day of tournament will be donated to charity or given to tournament volunteers.
25. Any addendum to these rules will be handed out at the rules meeting on Thursday June 24th at 7:00 p.m.
